

TERMS AND CONDITIONS

1. Introduction

These Terms and Conditions ("Terms") constitute a legally binding agreement between you ("User," "you," or "your") and Sustainability Economics News, ("Company," "we," "us," or "our") governing your access to and use of our website, services, content, and any related functionalities (collectively referred to as the "Website"). By accessing or using the Website, you acknowledge that you have read, understood, and agree to be bound by these Terms. If you do not agree to these Terms, we request to kindly cease all use of the Website.

2. Eligibility

- a. You are at least 18 years of age or the legal age of majority in your jurisdiction.

The arbitration shall take place in Singapore, and the language of the arbitration shall be English. The arbitral award shall be final and binding on both parties.

You agree to indemnify, defend, and hold harmless Sustainability Economics News, its affiliates, officers, directors, employees, agents, and licensors from and against any claims, liabilities, damages, losses, and expenses, including reasonable attorneys' fees and costs, arising out of or in any way connected with:
